The efficiency is shown in Figure 3.



The load regulation of the 20.0V output is shown in Figure 4.



2A/div, 50us/div



2A/div, 50us/div




Channel C2: **drain-source voltage**, -2.3V minimum voltage, 32.9V maximum voltage 10V/div, 2us/div




