

## MR16 LED replacement with TPS40211

- 5...12V DC / 12V +/-20% AC input voltage range

### 1 Startup

The startup waveform is shown in Figure 1. The input voltage is set at 12.0V AC with a electronic load on the output (18V @ 350mA).

Channel C1: **output current**  
200mA/div, 10ms/div

Channel C2: **input voltage**  
10V/div, 10ms/div

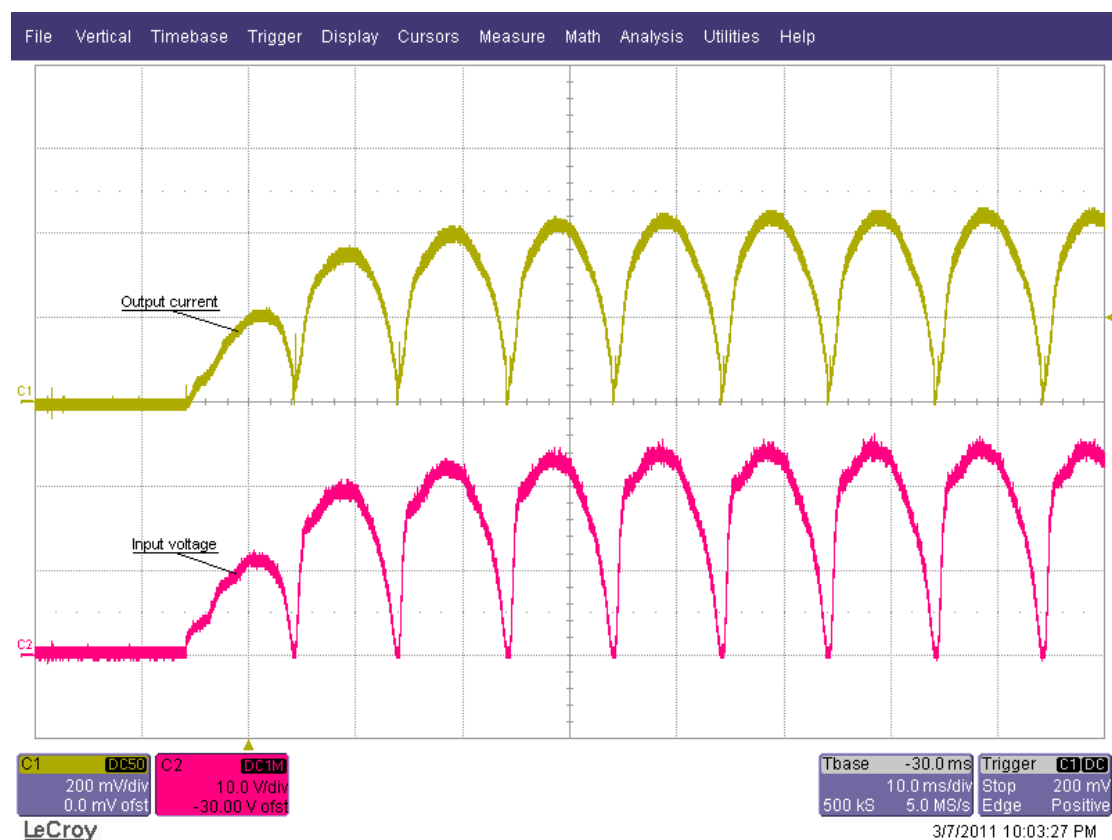

## 2 Output overvoltage protection

With no load attached on the output the output voltage is limited to approximately 40V.

10V/div, 200ms/div

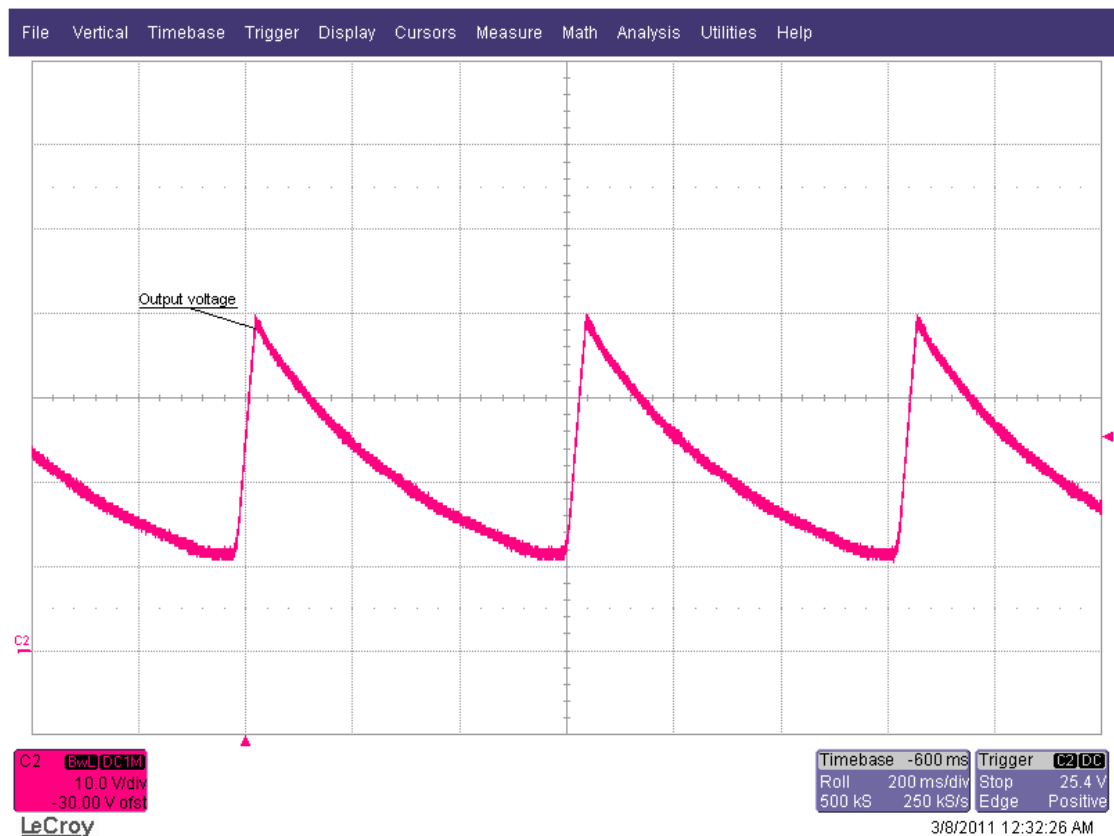
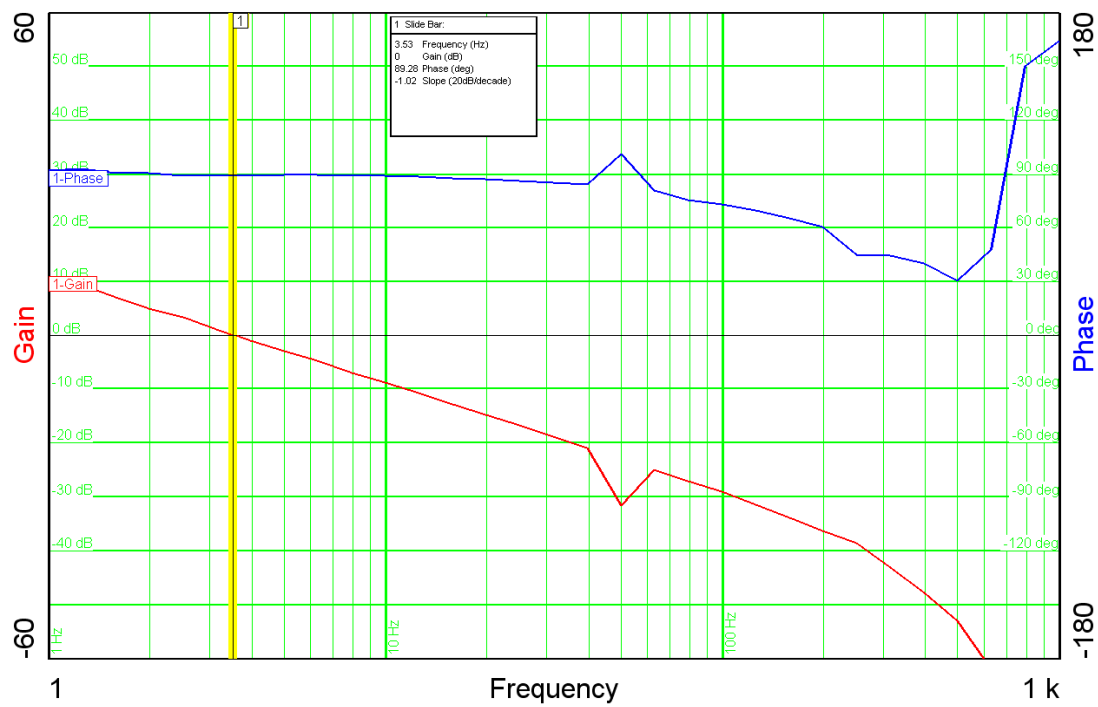

89 deg phase margin @ crossover frequency 3.5 Hz



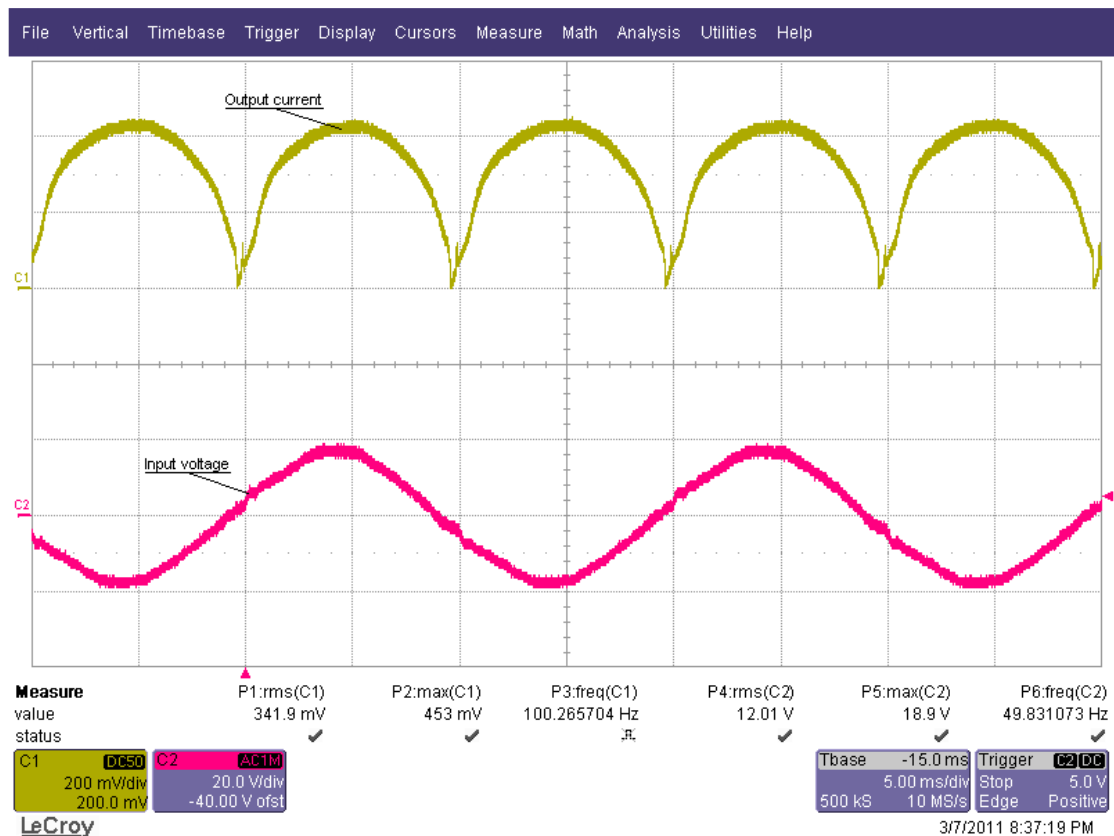

20V/div, 5ms/div



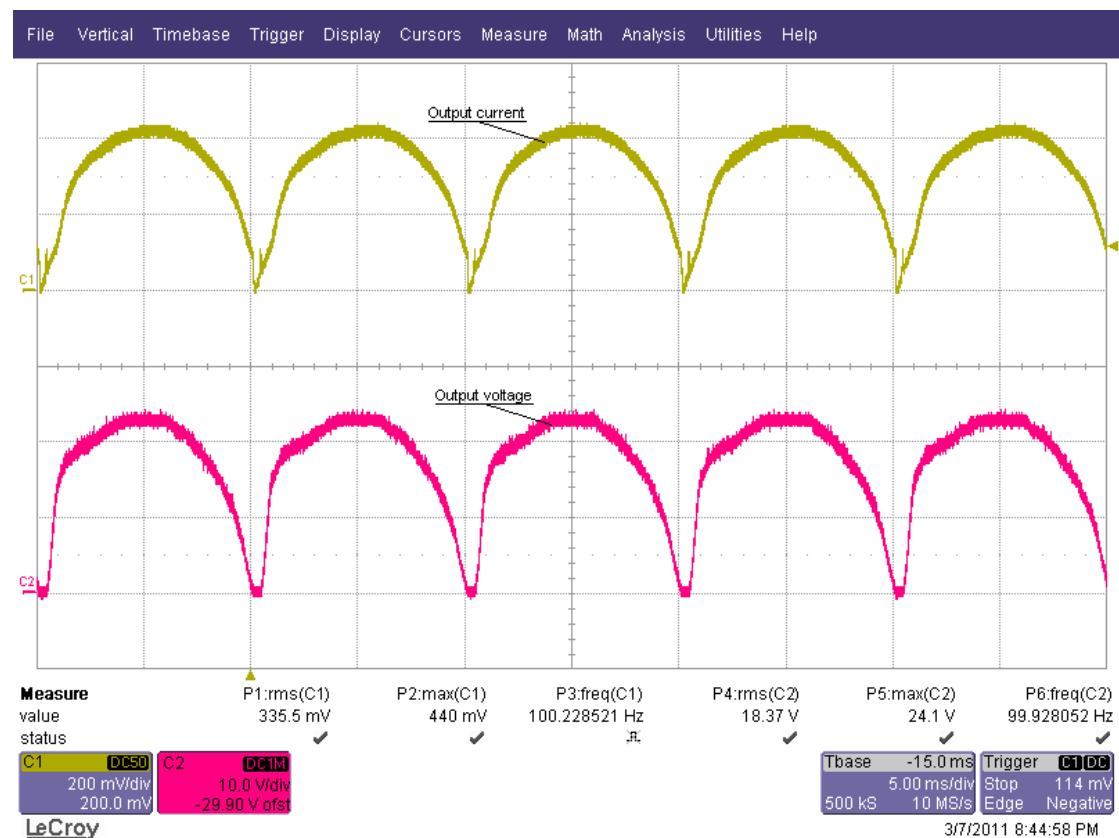

The thermal image (Figure 7) shows the circuit at an ambient temperature of 21 °C with an input voltage of 12.0V AC and an output current of 350mA @ 18V.

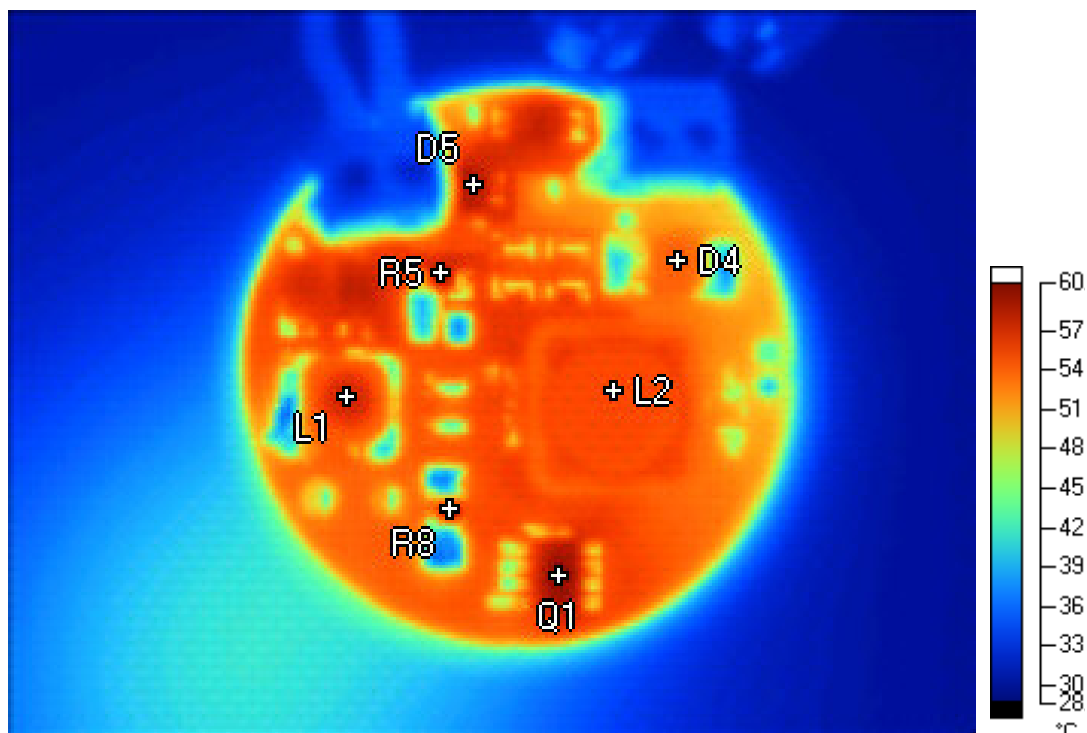
