

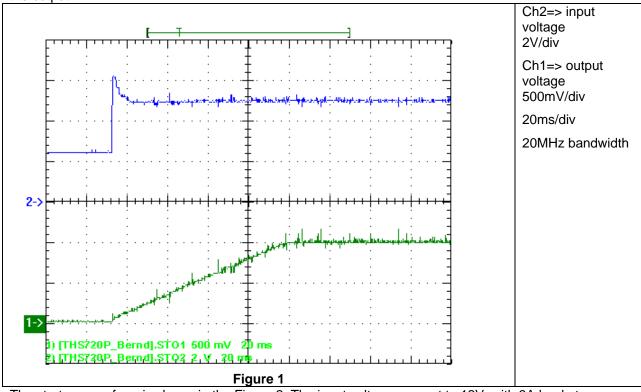

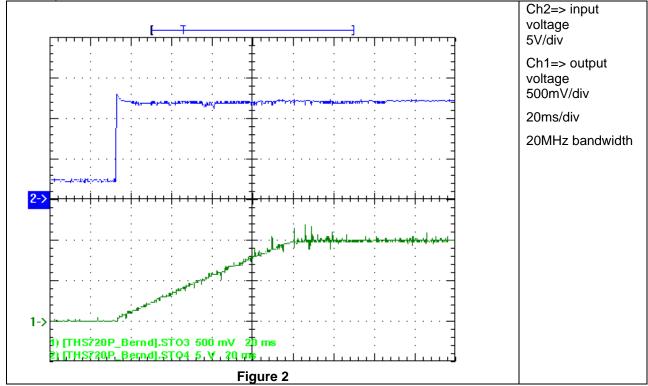


### 1 Startup

The startup waveform is shown in the Figure 1. The input voltage was set to 5V, with 3A load at the output.



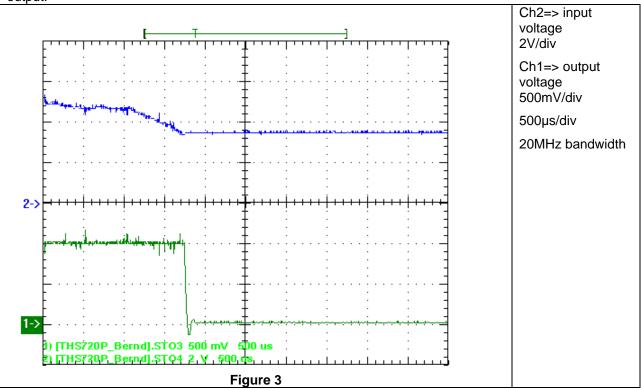
The startup waveform is shown in the Figure 2. The input voltage was set to 12V, with 3A load at the output.



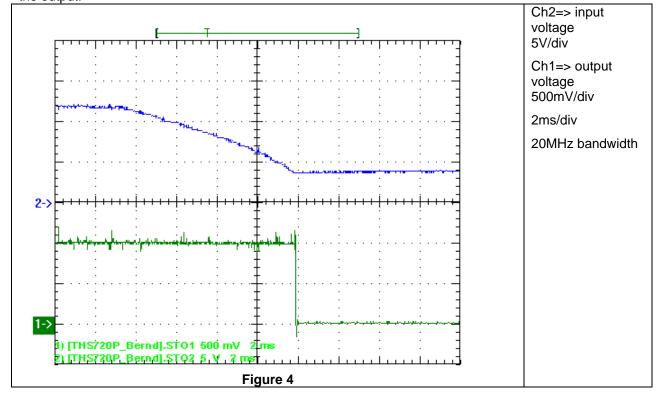


#### 2 Shutdown

The efficiency is shown in the Figure 5 below.

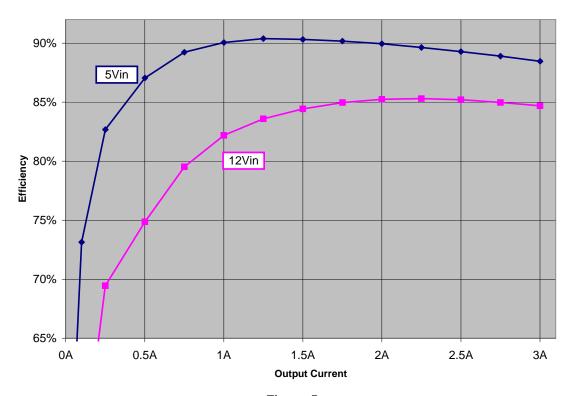

The load regulation is shown in Figure 6.

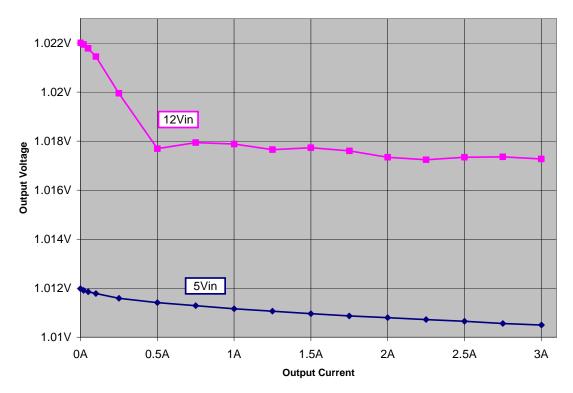

The line regulation at 3A output current is shown in Figure 7

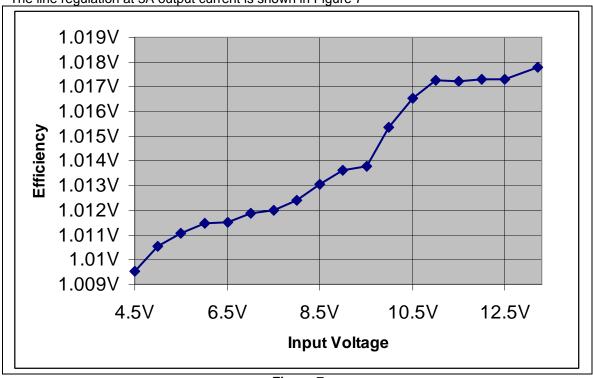

With the same measurement setup the efficiencies are shown in Figure 8.

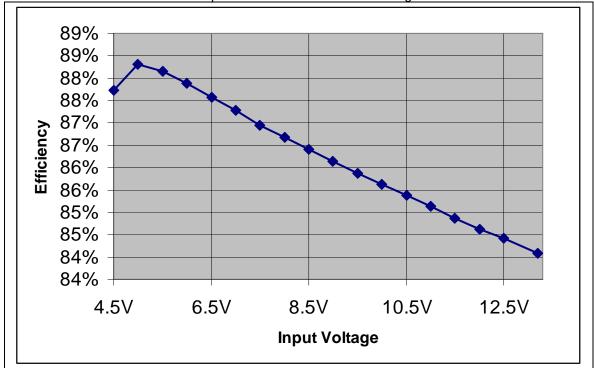
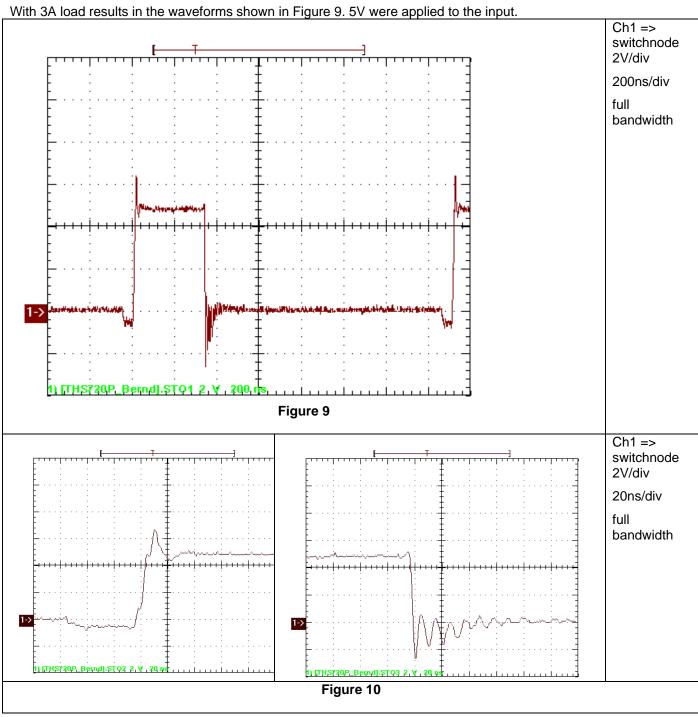

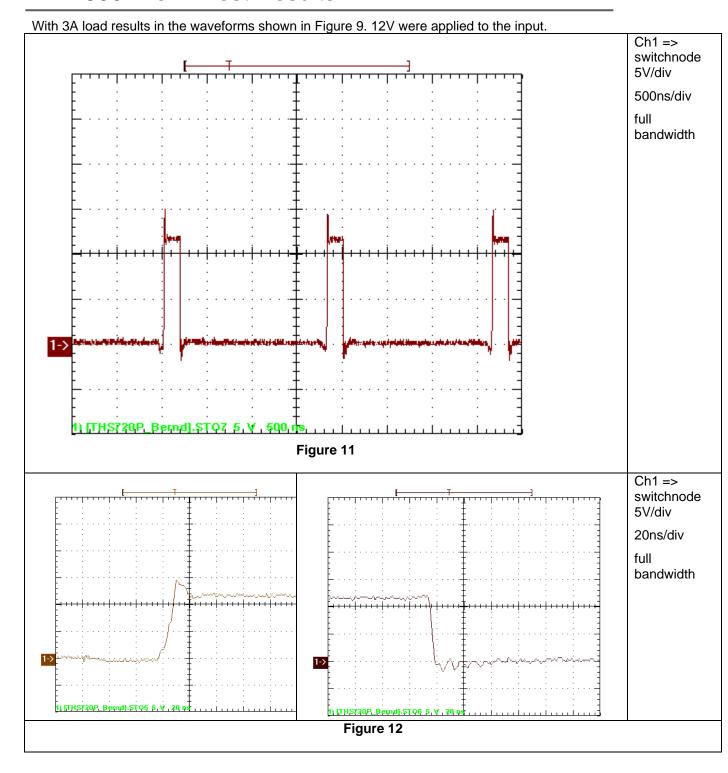

The output ripple voltage is displayed in Figure 13. The input voltage was set to 5V and 12V with output current 3A.

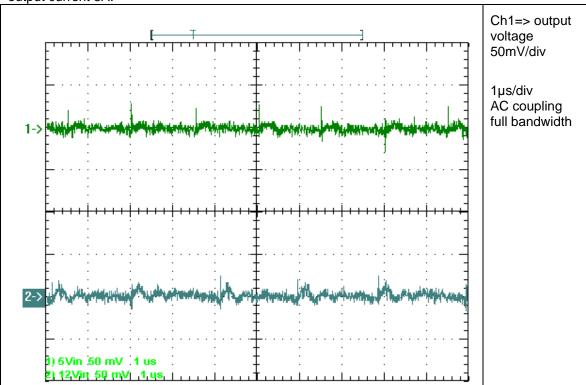

The input ripple voltage is displayed in Figure 14. The input voltage was set to 5V with output current 3A.

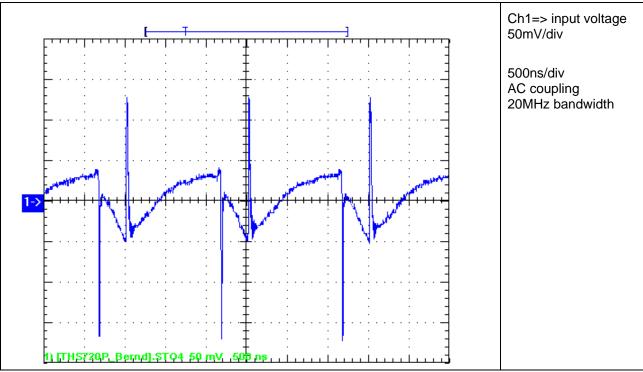

The input ripple voltage is displayed in Figure 15. The input voltage was set to 12V with output current 3A.

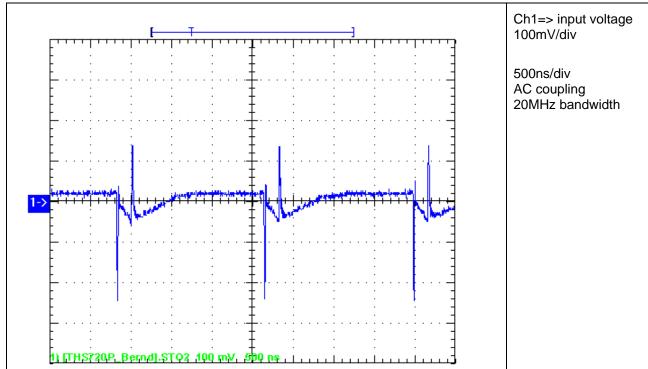
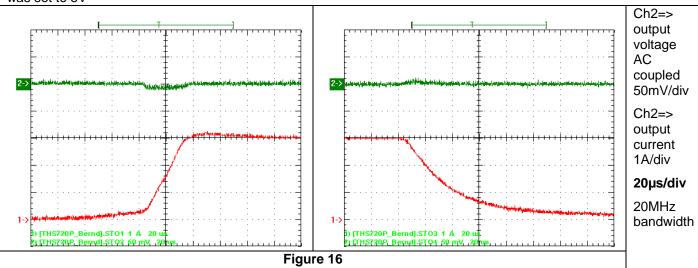

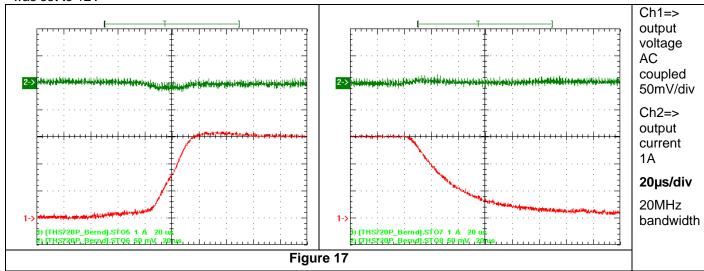


#### 8 Load Transients
